REQUIREMENTS FOR WEANLINGS
Kentucky/Kentucky Amateur Futurities: To show in the weaning division, the foal must be registered by the Kentucky State Fair post-entry closing date. ASHA State Futurities: All weanlings must be registered to show; please read State Futurity nomination forms carefully regarding specific registration deadlines.
