



# DNA Test/Conversion Request

## ATTENTION!

DNA testing to confirm parentage is mandatory for all horses for which an application is submitted in 2003 and thereafter. What does that mean? That the sire and dam for which an Application for Registration is submitted, on or after January 1, 2003, must have DNA test results on file. DNA testing will require either submission of a new blood sample or conversion of frozen serum.

### DNA Conversion

- If your mare or stallion was blood typed in 1992 or after, the fee for the DNA Conversion is \$30.
- If your mare or stallion was blood typed prior to 1992 or has never been blood typed, the fee for the blood typing and the DNA conversion is \$50.

To find out if a horse has blood type and/or DNA results on file or what year blood-typing was performed, you can use the horse data search on the ASHA web site at [www.saddlebred.com](http://www.saddlebred.com). Just click on the registry record section for the horse in question. You can also contact the Registry at (859) 259-2742.

**Note: Ordering your DNA conversions and/or DNA kits early might expedite processing of your registration applications, however, the registration process does not begin until the application forms are received in the ASR office.**
