



APPLICATION FOR CERTIFICATE OF ELIGIBILITY TO SHOW

The United States Equestrian Federation (USEF), the American Saddlebred Horse Association (ASHA) and the American Saddlebred Registry (ASR) require that all horses be entered and shown under their registered names and in the names of their recorded owners. However, a Certificate of Eligibility to Show may be issued to a person other than the recorded owner under the following circumstances:

1. The recorded owner of a horse may execute a Certificate of Eligibility to Show indicating a recorded owner's permission for an identified horse to be shown under the name of the person so designated.
2. The Certificate may be executed by the recorded owner when a horse is being purchased under an installment payment plan and the official Certificate of Registration has not yet been turned over to the purchaser; however, the execution of the Certificate is not limited to this circumstance.
3. ASR may execute a Certificate of Eligibility to Show in the name of a current unrecorded owner if, after reasonable investigation, the Registry is satisfied that it is not possible to document and record the complete chain of ownership and properly record the name of the current owner. In this case, photographic identification of the horse is required; identification by blood-typing may also be required at the Registry's discretion.
4. A Certificate of Eligibility to Show application must be filed with the ASR office with payment of the \$25.00 fee prior to the time the horse is shown. For Priority processing, an additional \$50.00 rush fee will be assessed. The Certificate of Eligibility to Show will be returned to the grantee with the official ASR seal affixed as endorsement that eligibility has been granted and has been recorded with ASR. A copy of this Certificate and a copy of the horse's Registration Certificate should be enclosed with horse show entries in order to comply with current USEF rules.
5. The Certificate may be terminated under any of the following circumstances: a) The recorded owner at any time by notifying ASR, in writing, stating that the Certificate is void as of a specified future date; b) If, after reasonable investigation, ASR identifies that a USEF or ASHA rule has been violated relating to a Certificate of Eligibility to Show, ASR reserves the right to notify USEF of such a violation (for example, judging/ownership conflict of interest); c) ASR may terminate any Certificate it has issued for any reasonable cause as determined by ASR.
