MEMORANDUM OF UNDERSTANDING BETWEEN UNITED STATES EQUESTRIAN FEDERATION, INC. AND THE AMERICAN SADDLEBRED HORSE ASSOCIATION

This Memorandum of Understanding ("Agreement") is made and entered into by and between the United States Equestrian Federation, Inc., with a principal place of business at 4047 Iron Works Parkway, Lexington, KY 40511 ("USEF") and The American Saddlebred Horse Association., with a principal place of business at 4083 Iron Works Parkway, Lexington, KY 40511 ("Recognized Affiliate" or "ASHA").

WITNESSETH:

- **WHEREAS**, USEF is a 501(c)(3) organization formed for the purpose of fostering national and international amateur sports competition in equestrian sports; and
- **WHEREAS,** USEF's Mission is to provide access to and increase participation in equestrian sports at all levels by ensuring fairness, safety, and enjoyment. And USEF's Vision is to bring the joy of horse sports to as many people as possible; and
- **WHEREAS,** ASHA recognizes that the USEF is the sole authority and governing body for equestrian sport in the United States as evidenced by the United States Olympic Committee's ("USOC") designation of USEF as the National Governing Body ("NGB") for the sport of equestrian in the United States; and
- **WHEREAS**, USEF is responsible, pursuant to the Ted Stevens Olympic and Amateur Sports Act ("Sports Act") and the USOC's Bylaws for the governance of equestrian sport within the United States; and
- **WHEREAS**, USEF has been recognized by the Federation Equestrian International ("FEI") as the National Federation ("NF") for the sport of equestrian in the United States; and
- **WHEREAS**, ASHA recognizes that USEF is the sole representative of equestrian sport at the USOC and the FEI, the international federation governing the sport of equestrian; and
- **WHEREAS**, under its Bylaws, as approved by the Board of Directors, USEF shall recognize no more than one Recognized Affiliate for each of its recognized breeds and disciplines; and
- **WHEREAS**, USEF recognizes that one of the purposes for which the ASHA was formed was to promote the best interest of the Saddlebred breed; and
- **WHEREAS,** ASHA, upon the effective date as defined in paragraph below, is recognized by USEF as the sole Recognized National Association representing the Arabian breed. Recognized Affiliate is responsible for the development and growth of the Saddlebred breed; and
- **WHEREAS**, ASHA and USEF wish to work in partnership in an effort to grow the sport, promote policies concerning the welfare of the horse through safe sport and clean sport and develop a positive working relationship.
- **NOW, THEREFORE**, for and in consideration of the mutual promises and covenants contained herein, plus other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties wish to memorialize the respective roles and responsibilities of each organization as it relates to ASHA's membership and recognition as a Recognized Affiliate:

1. USEF OBLIGATIONS

- 1.1 Serve as the NGB for equestrian sport in the United States and member of the USOC. USEF, as NGB, shall comply with all applicable laws and USOC requirements, including, without limiting the generality of the foregoing, compliance with the Sports Act, as amended, and with the USOC Bylaws.
- 1.2 Serve as the NF for equestrian sport in the United States and member of the FEI. Work together with the FEI to protect competition horses from any form of abuse, extend the universality of equestrian sport, and promote its visibility to the public.
- 1.3 Protect and support the welfare of horses by inspecting, monitoring, and testing to deter use of forbidden substances and other cruel, unsafe and/or unsportsmanlike practices and by adopting and enforcing rules to prohibit such practices.
- 1.4 Promote and encourage physical fitness, promote sportsmanship, and public participation in equestrian events and activities in the United States, and educate members and the public with respect thereto; assist organizations and individuals concerned with the development of programs for athletes in equestrian events; and provide services for members' common benefit.
- 1.5 Assure the right of an equestrian athlete to compete in any international equestrian competition conducted under USEF auspices or that of any other equestrian sports organization or person, unless USEF establishes that its denial was based on evidence that the organization or person conducting the competition did not meet the requirements of the Sports Act and the USOC Bylaws; and protect the right of any athlete to participate in athletic competition in equestrian events; and provide an equal opportunity to participate in amateur athletic competition without discrimination on the basis of race, color, religion (creed), gender, gender expression, age, national origin (ancestry), disability, marital status, sexual orientation, or military status and with fair notice and opportunity for a hearing to any amateur athlete, coach, trainer, manager, administrator, or official before declaring such individual ineligible to participate.
- 1.6 Provide the strongest possible U.S. representation internationally in each of the FEI disciplines, including providing a selection process for each major event.
- 1.7 Disseminate and distribute, or otherwise make readily available to equestrian participants, in a timely manner, the applicable rules and any changes to such rules of USEF, the USOC, and the FEI.
- 1.8 Provide a body of rules with which to govern equestrian sport at the national level, along with an effective means of enforcing them, and a judicial process that is fair to competitors while providing for optimum integrity within the sport; and provide for the swift and equitable resolution of conflicts and disputes involving its members.
- 1.9 Encourage and support equestrian sports programs for individuals with a disability and the participation of individuals with a disability in equestrian activity, including, where feasible, the expansion of opportunities for meaningful participation by individuals with a disability in programs of athletic competition for able-bodied individuals.
- 1.10 Provide effective and timely communication to every level of athlete, official, and organizer within the sport.
- 1.11 Develop interest and participation in equestrian sport throughout the United States and work with Recognized Affiliates, breed and discipline organizations, and other organizations to encourage participation.

- 1.12 Serve as the coordinating body for equestrian activity in the United States; exercise jurisdiction over international equestrian activities, and sanction international equestrian competition held in the United States; promote the sponsorship of international equestrian competition held inside and outside the United States.
- 1.13 Coordinate the calendar of competitions to ensure FEI level competitive opportunities domestically; enhance the level of national competition in all FEI disciplines; and provide for varying levels of regional and national competition in a wide variety of disciplines to increase the breadth and depth of the sport throughout the country.
- 1.14 Train and license officials.
- 1.15 License equestrian competitions in the United States in order to serve and promote the best interests of equestrian sport and expand and enhance the image of equestrian sports.
- 1.16 Encourage and support research in the areas of sports medicine and sports safety for both the human and the equine athlete and disseminate information that is developed.
- 1.17 Establish national goals and encourage attainment of those goals.
- 1.18 Aid the USOC in its mission to help U.S. athletes achieve sustained competitive excellence while inspiring all Americans and preserving the Olympic ideal.
- 1.19 Select and recommend to the USOC and FEI individuals and teams to represent the United States in the equestrian disciplines in international competitions.
- 1.20 Select and designate individuals and teams to represent the United States in equestrian international athletic competition (other than the Olympic, Pan American and Paralympic Games) and certify, in accordance with the applicable international rules, the eligibility of such individuals and teams.
- 1.21 Foster the development of the athletic facilities for use by equestrian athletes training for equestrian competitions and assist in making such facilities available to such athletes.
- 1.22 Provide equitable support and encouragement for participation by women and minorities.
- 1.23 Promptly review every request for sanction to hold an international competition in the U.S. or to sponsor U.S. amateur athletes to compete in international competition outside the U.S.
- 1.24 Implement, manage, and communicate a Safe Sport policy prohibiting various forms of misconduct i.e. sexual misconduct, harassment, physical misconduct, emotional misconduct, hazing, and bullying.
- 1.25 Act autonomously in the governance of equestrian sport, and independently determine and control all matters central to such governance, without delegating such determination and control or being subject to outside restraint.

RECOGNIZED AFFILIATE OBLIGATIONS.

General

2.1 Comply with and be bound by all applicable USEF Bylaws and USEF Rules.

- 2.2 ASHA agrees not to become affiliated with or recognize or support any other organization or association or group seeking recognition as the US NGB, as long as it remains an Affiliate as herein provided.
- 2.3 Recognize and reciprocate all USEF Hearing Committee decisions regarding the suspension, or other disciplinary action taken against a USEF or Recognized Affiliate member, provided that USEF bylaws are adhered to, and that USEF recognizes and reciprocates such decisions made by ASHA, provided ASHA has provided the same due process protections afforded USEF members.
- 2.4 Reciprocate all penalties issued by the U.S. Center for Safe Sport regardless of sport designation of the individual found in violation.
- 2.5 Recommend members to the appropriate USEF Committees and Councils, when applicable.
- 2.6 Adhere to USEF's Non-Discrimination Policy, which states:

The Federation does not discriminate on the basis of race, color, religion (creed), gender, gender expression, age, national origin (ancestry), disability, marital status, sexual orientation, or military status, in any of its activities or operations. We are committed to providing an inclusive and welcoming environment for all members and volunteers.

- 2.7 Maintain good standing with USEF.
- 2.8 Pay required Affiliate dues, which are currently \$200.00 but may change from time to time with reasonable notice to ASHA, and not to be materially different than dues charged other Affiliates.

Drugs and Medications/Safety and Welfare

- 2.9 Work in partnership with USEF to promote the USEF Drugs and Medication and Safe Sport Programs through Affiliate websites no later than January 1, 2018, and other mutually agreed upon and reasonable media avenues.
- 2.10 ASHA acknowledges the importance of adopting and developing programs and codes of conduct to address equine and human welfare.

Communications

2.11 Work in partnership with USEF to continue keeping the communication lines open between both organizations as has been over the years of this partnership.

Sport Growth and Participation

- 2.12 Work in partnership with USEF to promote, support, and administer, among other things, growth in competitions, participation, and education.
- 2.13 Provide USEF with contact information of all ASHA members who are not currently USEF members for the purpose of USEF providing each a free Fan membership for one year.

Licensing of Officials

- 2.14 A USEF official's license cannot be made contingent on obtaining a license or training (education) from the ASHA, except when USEF licenses education to ASHA.
- 2.15 At ASHA registered-only shows and divisions, officials may be ASHA or USEF licensed or both. At USEF-only and at USEF/ASHA Joint competitions, only USEF licensed officials will be used for USEF divisions.

Educating Officials

2.16 In collaboration with USEF, ASHA shall develop curricula for all levels of officiating for all classes within the Sport, administer, the education program, schedule clinics, choose clinicians, and create uniform criteria and requirements for all officials seeking licenses from ASHA or USEF.

Rules

2.17 Rules applicable to a particular competition shall be those of the sanctioning entity. USEF and ASHA shall work together to ensure consistency between their respective rules.

Competitions

- 2.18 Work with USEF to increase the number of USEF and/or joint USEF/ASHA licensed competitions including multiple levels of the sport at each competition.
- 2.19 ASHA will provide contact information for all competitors, owners and trainers competing at ASHA registered competitions that are not licensed with USEF

3. DISCUSSION AND DEVELOPMENT OPPORTUNITIES

USEF and ASHA will discuss the following areas of opportunity and if or when it is appropriate, memorialize it in writing:

- Promotion and marketing;
- Officials support
- Sport growth; and
- Other educational opportunities not listed herein.

4. NON-DISPARAGEMENT.

The Parties agree to avoid public criticism of each other at all costs, in the best interests of equestrian sport. This provision extends to each Parties' Board of Directors, committees, and staff.

5. TERM.

The term of this Agreement shall become effective upon full execution by the Parties If neither party initiates any process under USEF bylaws to terminate this Agreement, then the Agreement shall automatically be renewed for a period of three (3) years. The Parties shall meet at least once annually to review this Agreement and discuss its effectiveness and where appropriate, modify its terms as mutually agreed upon by the Parties.

6. TERMINATION.

It is agreed that ASHA may not be terminated, removed, or decertified as the Affiliate without being afforded a hearing as provided in the USEF bylaws along with all due process requirements attendant thereto.

7. <u>ENTIRE AGREEMENT</u>.

This Agreement shall represent the entire agreement between the Parties relating to the subject matter hereof and operates to the entire exclusion of any other agreement, memoranda, or prior understanding of any kind between the Parties.

8. NO ASSIGNMENT.

Neither party shall assign their rights, duties, or obligations under this Agreement, either in whole or in part, without the prior written consent of the other party.

9. <u>SEVERABILITY</u>.

If any provision of this Agreement is held to be illegal, invalid, or unenforceable under present or future laws effective during the term hereof, such provision shall be fully severable. This Agreement shall be construed and enforced as if such illegal, invalid, or unenforceable provision had never been a part of the Agreement, and the remaining provisions shall remain in full force and effect unaffected by such severance, provided that the severed provision(s) are not material to the overall purpose and operation of this Agreement.
