1 Point Penalties:

- Out of frame
- Hitting or stepping on a log, cone, marker, etc
- Break of gait at walk or jog for 2 strides or less
- Both front or hind feet in a single stride slot at walk or trot
- Skipping or failing to step into a required space
- Split log in lope-over
- Incorrect number of strides, if specifies
- Moving one or two steps on mount/dismount or ground tie except shifting for balance

Class: _____

3 Point Penalties:

- Wrong lead or cross lead
- Break of gait at lope (except to correct a wrong lead)
- Break of gait at walk or trot for more than 2 strides
- Moving 3-4 steps while mounting/dismounting or ground tie

5 Point Penalties:

- Blatant disobedience
- Spurring in front of cinch
- Use of hand to instill fear/praise
- Knocking over, stepping out of or falling off obstacle
- Dropping an object required to be carried
- 1st or 2nd cumulative refusal
- Letting go of gate
- 5 or more steps on mount/dismount or ground tie

Judge: _____

Off Pattern (Placed below horses performing all maneuvers):

- Incomplete Maneuver
- Eliminating or adding a maneuver
- 3rd refusal
- Repeated blatant disobedience
- failure to dally during the drag
- Use of 2 hands (except junior horses in a snaffle)
- More than 1 finger between split reins
- Any fingers between rommel reins
- failure to open and close the gait

Zero (0) Score/Disqualification:

- Lameness, abuse, leaving the working area
